# Terms and conditions between NMPAT and parents of children receiving music lessons billed directly by NMPAT

## Our commitment to you and your child

#### To provide:

- Regular lessons by a suitably qualified teacher, with access to up-to-date information about the best ways of playing and enjoying a musical instrument.
- The free loan of an instrument (subject to availability and not including guitars, keyboards or drum kits), particularly in the early stages of study.
- An annual written Pupil Profile, and the opportunity to discuss progress with your child's teacher.
- An opportunity to join your local Music and Performing Arts Centre. Supported membership is available to families in financial need, subject to certain criteria.

#### **Commitments from students**

Students will be expected to commit to their learning and play between lessons - remember that the more you play, the better you get! Students should:

- Attend lessons regularly and promptly so that continuity can be maintained.
- Make use of their practice diaries (which are provided by NMPAT) to write down what they should be practicing between lessons, and to record when they have practiced.
- Aim to make music every day, if they can.
- Always remember to think about posture.
- Listen for a good sound.
- Have fun when they play. That way, their personality will shine through the music.

#### Commitments from families

- To ensure your child looks after any instrument provided, as recommended by the teacher, and particularly for more expensive instruments to make adequate provision for loss or damage, for example through a musical instrument insurance policy.
- To encourage regular practice (essential for progress) and attendance at school instrumental ensembles and a music centre.
- To provide (where appropriate) their own music books, strings and reeds, as advised by the instrumental / vocal teacher.
- To pay any fees promptly when requested at the beginning of each teaching period.

#### **Term of Contract**

This Agreement will normally last for an academic year. Whilst your child remains at the same primary school, NMPAT will automatically renew this agreement for a further academic year, unless 5 teaching weeks' written notice is provided before the end of the Summer Term.

In the event of wishing to discontinue lessons at the end of a term (Autumn, Spring, Summer), you agree to give a minimum of five teaching weeks' notice in writing to NMPAT. You also agree that no refund of fees will be due to you for notice given within term.

Please be aware that, in some circumstances, where the five teaching weeks' notice overlaps with a new term, there may be an additional fee for lessons that take place in a new term that has not yet been paid for. You will only be charged for the number of lessons remaining in your notice period.

# Teaching Weeks and Lesson Length

Instrumental teaching will be provided for 33 weeks per academic year. Lessons will be delivered over three 11-week teaching periods (which may differ slightly to the school terms). Teaching is delivered during the school day.

Other than where school activities or child absences or pandemic/epidemic related school closures prevent us, we guarantee to deliver a minimum of 30 lessons in a full year.

NMPAT's standard tuition is provided as 15-minute lessons per child. This means that a productive amount of time can be spent with your child on a 1:1 basis, or that two students of similar standard can combine for a 30-minute lesson.

Recorder Groups, where offered, are provided as 30 minute lessons for a group of 5 - 7 pupils, or 15 minutes for groups of 2 - 4 pupils.

#### **Payment Terms**

Payments are to be made in advance of each 11-week teaching period.

If payment has not been made by the start of the relevant teaching period, we reserve the right to withhold lessons.

#### Missed Lessons: Teacher Absence

- Teachers are required to keep accurate records and sign in when they arrive at school.
- Lessons are delivered for 33 weeks across a school year; this gives 5 'catch up' weeks when teachers can visit schools to make up any missed lessons.
- Where lost teaching time is created by the inability of NMPAT teachers to deliver (e.g. due to the coronavirus pandemic/epidemic), then subject to potential 'catch up' referred to above, NMPAT will provide a refund against the lost teaching time.

Any refund for lost teaching time will be made at the end of an academic year, by a credit against the autumn term fees or, where tuition has been terminated, by means of a bank transfer.

#### Missed Lessons: Student Absence

- Student absences will not entitle you to a refund. This applies whether absences are caused by student illness, student absence, pandemic/epidemic related school closures or school activity conflicts, or any other cause outside NMPAT's control.
- Our teachers will do their best to 'catch up' lessons missed due to student absence, but no guarantee is given.
